The above described boat/Trailer or other as specified is hereinafter referred to as the "ITEM" and is defined to include the boat/trailer/other described above, its contents, attachments, equipment and all related to the ITEM.

### It is acknowledged by all parties to agree to the following:

Storage: Wrentham Sportsman's Association hereby leases to Owner, and Owner hereby rents from Wrentham Sportsman's Association, a winter storage space for the ITEM, defined above. Owner shall park the ITEM in the specified storage lot to the right of the house on the hill behind the tree line as you enter the main entrance, further more known as WSA boat storage area. It is understood that all storage areas are open air and are not rodent free; Items may have rodent damage. Owner shall take whatever precautions which they deem necessary and prudent to protect his ITEM from damage, and Wrentham Sportsman's Association shall have no liability whatsoever for any damage caused thereby.

Owner MUST provide a (one) 1 weeks' notice to an advisory board member prior to the date the ITEM is to be removed from the storage area to aid in the boards tracking of all items used and stored on club grounds.

All members are REQUIRED to put their last name, membership number and a contact number on the item to be used or stored on the Wrentham Sportsmen's Association property, no exceptions. Anything not marked properly will be removed from the property and the Wrentham Sportsmen's Association assumes no responsibility for any item not marked properly.



### Wrentham Sportsmen's Association

- > Term: This Agreement is an annual agreement and must be renewed annually. It is the members responsibility to insure the renewal of the agreement each year.
- All boats are to be removed off WSA property by December 1<sup>st</sup> or you MUST pay the winter storage fee of \$25 per year. Storage fees are accessed from December 1<sup>st</sup> till April 1<sup>st</sup>. If your ITEM is left on the property of the Wrentham Sportsmen's Association overnight even (one) 1 night between December 1<sup>st</sup> and April 1<sup>st</sup>, during these dates you are required to pay the storage fee. These fees are not and will not be prorated.

#### Insurance Requirement:

Owner's storage of the ITEM shall be at Wrentham Sportsman's Association facilities shall be at Owner's sole risk. Owner shall at all times maintain adequate insurance on the ITEM and shall take any and all necessary precautions to secure the ITEM while stored on Wrentham Sportsman's Association premises. Owner acknowledges it is Owner's responsibility to obtain reimbursement for all insurance claims.

Waiver of Liability and Indemnification: Owners storage of items shall be at the owner's sole risk. Wrentham sportsmen's Association. Its employees and officers shall have no liability to theft, damage or vandalism of the ITEM or its contents while being used, stored or transported by Wrentham Sportsmen's Association employees or officers. Owner hereby holds the Wrentham Sportsmen's Association, its employees and officers harmless and indemnifies the Wrentham Sportsmen's Association, its employees and officers against any and all losses, damages, and or causes of action associated with the use, storage or transportation the ITEM. Owner agrees to hold harmless and indemnifies the Wrentham Sportsmen's Association, its employees and officers from any and all losses, damages, demands, actions, causes of action, or liability of any kind for injuries to any persons or property resulting from the usage, storage and or transportation of the ITEM; and owner hereby agrees to hold harmless and indemnifies the Wrentham Sportsmen's Association, its employees and officers from any and all losses, damages, demands, causes of action or liabilities to any person or entity by reason of any act or failure to act on the part of the owner, their agent, employee, invitee or guest in the use, storage or transportation of ITEM.
